1. Consignor agrees to allow WeeCycleIt! to sell any or all items checked into the sale. Consignor sets the price for each item and whether or not it should be discounted at the half price sale. WeeCycleIt! reserves the right to reject any item that does not meet qualifications or may be inappropriate. Qualifications are available on the website at: www.WeCycleIt.com.
2. WeeCycleIt! agrees to pay Consignor 70% of the total sales amount (80% for Volunteer working break-down shift). The Consignor understands that an additional \$10.00 administrative fee is deducted from their share.
3. Consignor also understands that all items not picked up by **5:00pm Saturday, May 5th** become the property of WeeCycleIt! and will be donated to a non-profit charity. Items cannot be held after that time.
4. Consignor agrees to **hold harmless and make no claim** against WeeCycleIt!, Shannon Woody, any volunteer or paid participants in the sale **for any damage, theft or loss** of any items consigned to WeeCycleIt!. Consignor assumes the risks of these events occurring by participating in the sale.
5. Consignor agrees to **waive any and all claims for personal injury** resulting in participation in the sale from whatever cause against WeeCycleIt!, Shannon Woody, any volunteer or paid participants in the sale.
